

**IN VIEW OF:** Note SEAM N.G. No. 255 of June 6, 2018, by which it requests the declaration of a Protected Wildlife Area under Dominion, and

**WHEREAS:** Article 26 of Law No. 352/1994 on Protected Wilderness Areas establishes that "The declaration of a Protected Wilderness Area under private domain shall be made by Executive Decree or Law with the prior requirement of a technical justification containing a general diagnosis of the particular characteristics of the biological, physical and cultural resources existing in the area and their importance for the current and future conservation of the ecosystems, ecological processes and natural resources".

That by Resolution N° 79/2018 issued by the Secretariat of the Environment (SEAM) "By which the Technical Justification for the creation of the Natural Reserve under Private Domain, called "Toldo Cue" is approved, the prerequisite for this declaration provided for in the aforementioned legal rule has been fulfilled, with an area of 1017 hectares, 6745 m<sup>2</sup>, (One thousand seventeen hectares, six thousand seven hundred and forty-five square meters), registered in the General Directorate of Public Records, under Farm N° 4092, Registry No. 14493 and Farm N° 404RP01, Registry No. 14494. In the Fortin Gral. Delgado area, District Gral. José María Bruguez, Department of Presidente Hayes.

That Law No. 1561/2000, "Creating the National Environmental System, the National Environmental Council and the Secretariat of the Environment, in its Article 14, Section k), establishes that the Secretariat of the Environment becomes the enforcement authority of Law No. 352/1994 "On Protected Wildlife Areas, thus substituting the National Parks and Wildlife Directorate.

That by Ruling A.J.No. 162/2018 of April 20, 2018, the Legal Counsel, with the favorable opinion of the Directorate of Protected Wildlife Areas (DASP) and the General Directorate for the Protection of Biodiversity (DGPCB) has not objected to the request of the Secretariat of the Environment.

**THEREFORE**, in exercise of its constitutional powers,

**THE PRESIDENT OF THE REPUBLIC OF PARAGUAY**

**D E C R E E S :**

**Art. 1°.-** To declare as a Protected Wildlife Area, under Private Domain the Natural Reserve called "Toldo Cue", with an area of 1017 ha, 6745 m<sup>2</sup>, (One thousand and seventeen hectares, six thousand seven hundred and forty-five square meters), registered in the General Directorate of Public Records, under Farm No. 4092, Register No. 14493 and Farm No. 404RP01 Register No. 14494, place Zone Fortín Gral. José Maria Bruguez District, Department of Presidente Hayes, according to the following technical data and in accordance with the attached Expert Report:

The dimensions, boundaries and surface area of the Private Natural Reserve are as follows:

**LINE 1-2:** bearing N 02'15'59" E (North two degrees fifteen minutes fifty-nine seconds East), measuring 4025.59 meters (Four thousand twenty-five meters, fifty-nine centimeters); and it borders with Rights of Casto Jaime Cristaldo.

**LINE 2-3:** bearing N 00'23'51" W (North zero degrees twenty-three minutes and fifty-one seconds West), measuring 539.02 meters. (Five hundred and thirty-nine meters two centimeters); and it borders with Rights of Casto Jaime Cristaldo.

**LINE 3-4:** bearing S 45'00'00" E (South forty-five degrees East), measuring 160.36 m. (One hundred and sixty meters thirty-six centimeters); and bordering with Rights of Casto Jaime Cristaldo.

**LINE 4-5:** bearing S 44'07'07" E (South forty-four degrees seven minutes seven seconds East), measuring 744.60 m. (Seven hundred and forty-four meters sixty centimeters); and bordering with Rights of Casto Jaime Cristaldo.

**LINE 5-6:** bearing S 43'27'07" E (South forty-three degrees twenty-seven minutes seven seconds East), measuring 423.95 m. (four hundred twenty-three meters ninety-five centimeters); and bordering with Rights of Casto Jaime Cristaldo.

**LINE 6-7:** bearing N 84'33'35" E (North eighty-four degrees thirty-three minutes thirty-five seconds East), measuring 341.71 m. (Three hundred and forty-one meters seventy-one centimeters); and it borders with Rights of Casto Jaime Cristaldo.

**LINE 7-8:** bearing N 68'37'46" E (North sixty-eight degrees thirty seven minutes forty six seconds East), measuring 400.07 m. (Four hundred meters seven centimeters); and it borders with Rights of Casto Jaime Cristaldo.

**LINE 8-9:** bearing S 81'52'12" E (South eighty-one degrees fifty-two minutes and twelve seconds East), measuring 343.62 m. (Three hundred and forty-three meters sixty-two centimeters); and bordering with Rights of Casto Jaime Cristaldo.

**LINE 9-10:** bearing N 47'43'35" E (North forty seven degrees forty three minutes and thirty five seconds East), measuring 474.58 meters. (Four hundred and seventy-four meters and fifty-eight centimeters); and it borders with Rights of Casto Jaime Cristaldo.

**LINE 10-11:** bearing S 72'21'01" E (South seventy-two degrees twenty-one minutes one second East), measuring 171.76 m. (One hundred and seventy-one meters and seventy-six centimeters); and it borders with Rights of Casto Jaime Cristaldo.

**LINE 11-12:** bearing S 02'56 40" W (South two degrees fifty six minutes and forty seconds West), measuring 879,56 m. (Eight hundred and seventy-nine meters fifty-six centimeters); and borders with Fraction 4.

**LINE 12-13:** bearing S 03'16'03" W (South three degrees sixteen minutes three seconds West), measuring 1582.03 m. (One thousand five hundred and eighty-two meters three centimeters); and borders with Fraction 4.

**LINE 14-15:** bearing N. 59'02'11" W (North fifty-nine degrees two minutes eleven seconds West), measuring 181.15 m. (One hundred and eighty-one meters fifteen centimeters); and bordering with Rights of Casto Jaime Cristaldo.

**LINE 15-16:** bearing N 36'01'39" W (North thirty-six degrees one minute thirty-nine seconds West, measuring 316.92 m. (three hundred and sixteen meters ninety-two centimeters); and it borders with Rights of Casto Jaime Cristaldo.

**LINE 16-17:** bearing S 43'01'30" W (South forty-three degrees one minute thirty seconds West), measuring 159.36 m. (One hundred and fifty-nine meters thirty-six centimeters); and bordering with Rights of Casto Jaime Cristaldo.

**LINE 17-18:** bearing S 45'46'40" W (South forty-five degrees forty-six minutes forty seconds West), measuring 298.72 m. (Two hundred and ninety-eight meters seventy-two centimeters); and borders with Rights of Casto Jaime Cristaldo.

**LINE 18-19:** bearing N 53'07'48" W (North fifty-three degrees seven minutes forty-eight seconds West), measuring 158.75 m. (One hundred and fifty-eight meters seventy-five centimeters); and borders with Rights of Casto Jaime Cristaldo.

**LINE 19-20:** bearing S 44'06 01" W (South forty-four degrees six minutes one second West), measuring 123.72 m. (One hundred and twenty-three meters seventy-two centimeters); and borders with Rights of Casto Jaime Cristaldo.

**LINE 20-21:** bearing S 03'45'06" W (South three degrees forty-five minutes and six seconds West), measuring 474.79 m. (Four hundred and seventy-four meters seventy-nine centimeters); and it borders with Rights of Casto Jaime Cristaldo.

**LINE 21-22:** bearing S 76'17'35" E (South seventy-six degrees seventeen minutes thirty-five seconds East), measuring 327.77 m. (Three hundred and twenty-seven meters seventy seven centimeters); and it borders with Rights of Casto Jaime Cristaldo.

**BY WHICH THE NATURAL RESERVE CALLED "TOLDO CUE" IS DECLARED AS A PROTECTED WILD AREA UNDER PRIVATE DOMAIN.**

**LINE 24-25:** bearing S 68°51'37" E (South sixty-eight degrees fifty one minutes thirty seven seconds East), measuring 317.30 m. (Three hundred seventeen meters thirty centimeters); and borders with Rights of Casto Jaime Cristaldo.

**LINE 25-26:** bearing S 03°16 '03" W (South three degrees sixteen minutes three seconds West), measuring 2000.24 m. (Two thousand meters twenty-four centimeters); and borders with Fraction 4.

**LINE 26-1:** bearing S 76°17 34" E (South seventy-six degrees seventeen minutes thirty four seconds East), measuring 2460.19 m. (Two thousand four hundred and sixty meters nineteen centimeters); and it borders with Pilcomayo River.

**Polygonal area:** 979 ha 2900 m<sup>2</sup> (Nine hundred seventy-nine hectares, two thousand nine hundred square meters).

**Extrapolygonal area:** 38 ha 3845 m<sup>2</sup> (Thirty-eight hectares, three thousand eight hundred and forty-five square meters).

**Total area:** 1017 ha 6745 m<sup>2</sup> (One thousand seventeen hectares six thousand seven hundred and forty-five square meters).

**Art. 2°.-** Order the registration of this general declaration in the Public Registries, for which purpose a note of the same shall be made on the registration of the property described in Article 1" of this Decree.

**Art. 3°.-** Grant the benefits provided for in Articles 55, 56 and 57 of Law No. 352/1994 "On Protected Wildlife Areas", as provided for in Article 30 of the aforementioned law.

**Art. 4°.-** The owner, within a period not to exceed six (6) months, must present the Area Management Plan as well as the plan of the area showing the points that close its boundaries.

**Art. 5°.-** This Decree shall be countersigned by the Minister of Internal Affairs.

**Art. 6°.-** Communicate, publish and insert in the Official Registry.
